## **Section 2 Object of the Contract**

T&B Photo will fulfill Legacy Circle 2025 for The Member by providing a one-of-a-kind photograph (hereinafter referred to as “The Photograph”) as described in Section 3, under the terms set by T&B Photo and agreed upon by The Member.

The Photograph will be made by the Photographer (hereinafter referred to as “Photographer”) of their choosing, as described in Section 4, under the terms set by T&B Photo and agreed upon by The Member.

T&B Photo will fulfill the Artwork (hereinafter referred to as “The Artwork”) included in Legacy Circle 2025 as described in Section 5, under the terms set by T&B Photo and agreed upon by The Member.

T&B Photo will allow The Member to take advantage of the services provided with the purchase of Legacy Circle 2025, as described in section 6, under the terms set by T&B Photo and agreed upon by The Member.

If the Member purchases additional add-ons as described in Section 7, T&B Photo will fulfill them under the terms set by T&B Photo and agreed upon by the Member.

The Member will pay T&B Photo as described in Section 8, under the terms set by T&B Photo and agreed upon by The Member.

T&B Photo disclaimers to The Member is listed as described in Section 9, under the terms set by T&B Photo and agreed upon by The Member.

T&B Photo will provide The Member with a Letter of Authenticity under the terms set by T&B Photo and agreed upon by The Member, as described in Section 10.

The copyrights, as described in Section 11, are under the terms set by T&B Photo and agreed upon by The Member.

## **Section 3 The Photograph**

Drone and aerial photography are NOT an option.

All Legacy Circle 2025 Photographs will remain unseen to the public, including The Member, and MUST be included in a show at Todd and Brad Reed Photography from June 19<sup>th</sup> to July 17<sup>th</sup>, 2025. A private unveiling will be held on June 19<sup>th</sup> for The Members. At the conclusion of the show, The Artwork will be available, as listed in Section 5.

### **Section 3 The Photograph continued**

The Member will have their choice of a horizontal or vertical orientation for The Photograph.

The Member will have a choice of location; these options can be found in Section 12.

Once all Parties of the Contract have signed the Contract for Team Reed's Legacy Circle 2025, The Member will NOT be able to change their choice of location, or orientation of The Photograph.

While the Photographer could make many photos while shooting for Legacy Circle 2025, T&B Photo will choose one final photographic image to create the *One-of-One* print and The Artwork for The Member.

T&B Photo are allowed to use photos made on the same day and/or location to sell in all normal aspects of their business as Todd and Brad Reed Photography, LLC AS LONG AS the photos are not similar to The Photograph.

### **Section 4 Photographer**

Five Legacy Circle 2025 openings will be available per each of the three photographers: Todd Reed, Brad Reed, and Rachel Gaudette. The Member will have their choice of Photographer until all five openings per photographer have been filled.

Once all Parties of the Contract have signed the Contract for Team Reed's Legacy Circle 2025, The Member will NOT be able to change their choice of Photographer.

### **Section 5 The Artwork**

T&B Photo will provide The Member a signed and numbered 38 x 57-inch One-of-One Gallery Wrapped Canvas of The Photograph.

T&B Photo will provide The Member with 50 custom greeting cards showcasing The Photograph and the story of how the Photographer made the image on the back.

T&B Photo will provide The Member with a custom Christmas ornament displaying The Photograph.

The Artwork will be available to The Member by July 19<sup>th</sup> 2025, either by pick up at Todd and Brad Reed Photography in Ludington or by shipping to an address in the continental U.S. they provide (at no cost to The Member).

T&B Photo will not be able to replicate a scene you have previously witnessed at said property or locations. T&B Photo will work to the best of their ability to create the highest quality art given the circumstances available to them on their day(s) of shooting.

### *Add-On 2*

What better way to commemorate this unique Photograph than with a one-of-a-kind painting by Brad Reed's daughter, Julia Reed. Julia is a national award-winning painter who will transform The Photograph beautifully onto a 16 x 24-inch wrapped painting. The additional fee for your custom painting would be \$2500. (*The painting will be delivered in June of 2026.*)

Julia may enter ArtPrize 2025 with the paintings purchased in Legacy Circle 2025. By purchasing Add-On 2, you permit Julia Reed to use these in this art competition.

## Section 8 The Pay

If The Member pays via Credit Card, a 3% credit card fee will be added to the total payment amount.
